D1072 series are isolated Intrinsically Safe Associated Apparatus located in Non Hazardous Locations or Class I, Division 2, Groups A, B, C, D, Temperature Code T4 and Class I, Zone 2, Group IIC, IIB, IIA Temperature Code T4 Hazardous Locations (according to ANSI/ISA 12.12.01-13, UL60079-15, CSA-C22.2 No. 213-M1987,

CAN/CSA C22.2 No. 60079-15:12) within the specified operating temperature limits Tamb -20 to +60 °C, and connected to equipment with a maximum limit for AC power supply Um of 250 Vrms. When installed in Class I, Division 2 or Class I, Zone 2 Hazardous Locations, the module must be mounted in supplemental enclosure meeting at least IP54 degree protection. Not to be connected to control equipment that uses or generates more than 250 Vrms or Vdc with respect to earth ground.

D1072 series must be installed, operated and maintained only by qualified personnel, in accordance to the relevant national/international installation standards

(e.g. ANSI/ISA RP12.06.01 Installation of Intrinsically Safe System for Hazardous (Classified) Locations, National Electrical Code NEC ANSI/ NFPA 70 Section 504 and 505,

Canadian Electrical Code CEC) following the established installation rules, particular care shall be given to segregation and clear identification of I.S. conductors from non I.S. ones. De-energize power source (turn off power supply voltage) before plug or unplug the terminal blocks when installed in Hazardous Locations or unless area is known to be nonhazardous.

Warning: substitution of components may impair Intrinsic Safety and suitability for Division 2, Zone 2.

The enclosure provides, according to EN60529, an IP20 minimum degree of mechanical protection (or similar to NEMA Standard 250 type 1) for indoor installation, outdoor installation requires an additional enclosure with higher degree of protection (i.e. IP54 to IP65 or NEMA type 12-13) consistent with the effective operating environment of the specific installation. Units must be protected against dirt, dust, extreme mechanical (e.g. vibration, impact and shock) and thermal stress, and casual contacts.

If enclosure needs to be cleaned use only a cloth lightly moistened by a mixture of detergent in water.

Electrostatic Hazard: to avoid electrostatic hazard, the enclosure of D1072 must be cleaned only with a damp or antistatic cloth.


Connection: by polarized plug-in disconnect screw terminal blocks to accomodate terminations up to 2.5 mm².

This associated apparatus may also be connected to simple apparatus as defined in Article 504.2 and installed and temperature classified in accordance with article 504.10(B) of the National Electrical Code (ANSI/NFPA 70), or other local codes, as applicable.

Where multiple circuits extend from the same piece of associated apparatus, they must be installed in separate cables or in one cable having suitable insulation. Refer to Article 504.30(B) of the National Electrical Code (ANSI/NFPA 70) and Instrument Society of America Recommended Practice ISA RP12.6 for installing intrinsically safe equipment.

This associated apparatus has not been evaluated for use in combination with another associated apparatus.

This associated apparatus provides galvanically isolated intrinsically safe circuits.

NOTE: for installations in which both the Ci and Li of the Intrinsically Safe apparatus exceed 1 % of the Co and Lo parameters of the Associated Apparatus (excluding the cable), then 50 % of Co and Lo parameters are applicable and shall not be exceeded (50 % of the Co and Lo become the limits which must include the cable such that

The reduced capacitance of the external circuit (including cable) shall not be greater than 1uF for Groups I, IIA (Group D), IIB (Group C), and 600nF for Group IIC (Group A and B).

Capacitance and inductance of the field wiring from the intrinsically safe equipment to the associated apparatus shall be calculated and must be included in the system calculations as shown in the entity parameters table.

If the cable parameters are unknown, the following may be used:

Capacitance 60pF per foot (180pF per meter), Inductance 0.20µH per foot (0.60µH per meter).
